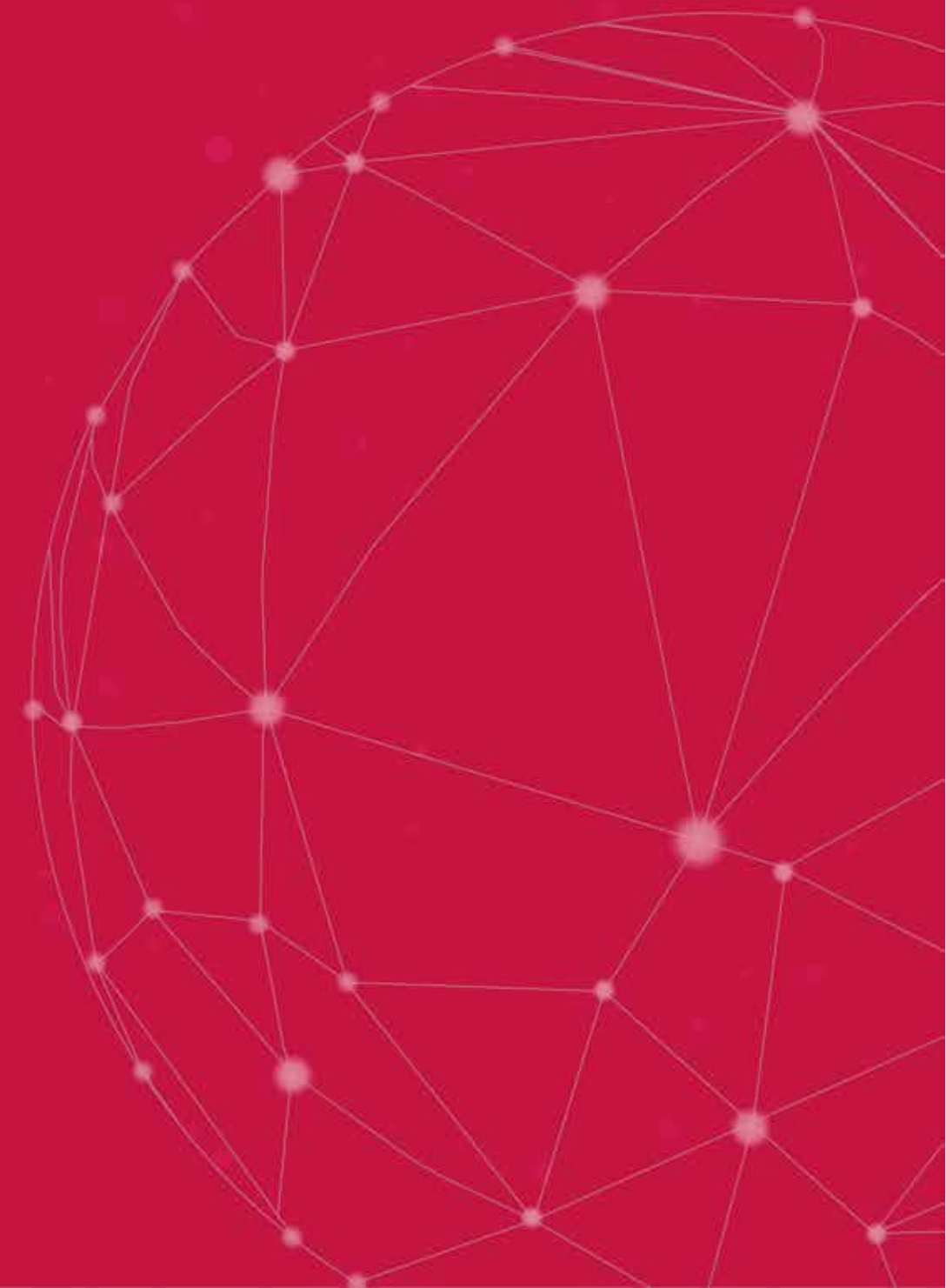

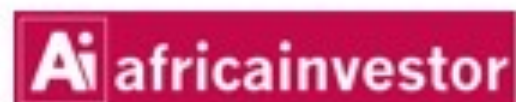
**Steps African Asset Owners should take to leverage their investment on the continent** and to bring in global partners to invest alongside.
